### High School Mock Trial Coach's Tremors

"My most rewarding courtroom experience required me to remain silent. Fourteen students from Arsenal Tech High School in Indianapolis, Indiana were presenting their cases in the murder trial of Rowan Hyde. We had planned, we had practiced, and we had prepared, but now they had to make their case. They were on their own and I was on the sidelines, where I belonged.

The Mock Trial program is unparalleled in its ability to challenge and enrich Indiana's high-school students. Students work for months with teachers and attorneys to prepare a case for trial. They compete against teams from across the state and present their cases before a panel of judges (local volunteer attorneys). No other program better prepares students to understand our legal system, to think critically, or to speak effectively. While there is no shortage of students wanting to participate, there is a dearth of attorneys who volunteer to judge or coach a team. I encourage you to get off the sidelines and volunteer to judge or coach for a local school. Just be prepared to return to the sidelines when court is in session, it's where we belong."

### Four Teams to Represent Indiana Nationally

Will Indiana ever be known for academics instead of sports? You can help change a few minds. Indiana has three high schools and one middle school team representing it this spring in the national finals for *We the People: the Citizen and the Constitution* and the National High School Mock Trial Championship.

events. The Indiana Bar Foundation's board implemented a policy last year of supporting both the *We the People* and the Indiana Mock Trial champion teams. Cathedral High School, Indianapolis, won the Indiana State Finals for the *We the People* program in December, and they will represent Indiana at the national competition in April. Cathedral's teacher, Jill Baisinger, has taken a team to nationals three times in six years.



Plainfield High School, the second place team, was offered a chance to compete at nationals as a wild card team. This is Plainfield's second time to attend the national competition.
