- **We the People Regional Competitions** – November 2018

Choose from the following locations: Indianapolis, Valparaiso, Fort Wayne, Evansville

At each regional competition, up to 250 middle school and 300 high school students (exact numbers vary by location), their parents, teachers, and 36 judges will participate at the regional competition closest to their school.

- **Coalition for Court Access Conference Luncheon** – November 2, 2018, Indianapolis

Up to 200 legal aid and pro bono providers from around the state, including civil legal aid and pro bono lawyers, law school clinicians, members of the judiciary and Court staff will attend this day-long conference. A prominent speaker is invited to give the luncheon keynote address.

- **We the People State Finals** – December 9-11, 2018, Indianapolis

300 middle school and 400 high school students, their parents, teachers, and 90 judges from around the state will attend.

- **Annual Awards Dinner** – December 9, 2018, Indianapolis

Invited guests include state officials, attorneys, federal, state, and trial court judges, volunteers, and honorees. Celebrates pro bono service, law-related education and community service by the legal profession and other Hoosiers. New Fellows and Keystone Society members will also be honored.

- **Indiana High School Mock Trial Regional Competitions** – February 2019

Choose from the following locations: Indianapolis, Evansville, Hammond, South Bend

A total of 400 high school students plus their parents, attorneys, and volunteers attend the regional competition closest to their school.

- **Indiana High School Mock Trial State Competition** – March 9-10, 2019, Indianapolis

190 high school students plus their parents, attorneys, and volunteers attend.

- **National Competition Fund** – Spring 2019

Indiana teams compete and often finish in the top 10 at national competitions. These students need your help focusing on preparing for the competition rather than fundraising for it. Your donation to this fund helps the winning High School Mock Trial and We the People teams travel to their national competition annually. This is a \$25,000 investment the Foundation makes in educating tomorrow's leaders each year.

- **We the People Elementary Showcase** – May 2019, Indianapolis
