2019 United States Senate Youth Program – INDIANA SUMMARY OF RULES AND CRITERIA

I. In order to be eligible for nomination, each nominee must be:

- a. A permanent resident of the United States;
- b. A resident of Indiana;
- c. Currently enrolled for the entire year in the 11th or 12th grade in a public or private high school in Indiana; home-school students are also eligible; and
- d. Currently serving in an elected or appointed capacity for the entire academic year, in student government or in a civic or educational organization, representing a constituency, such as:
 - i. Student body president, vice-president, secretary, treasurer, or
 - ii. Class president, vice-president, secretary, treasurer, or
 - iii. Student council representative, or
 - iv. Student representative to district, regional, or state-level civic or educational organizations
 - * The positions listed below DO NOT qualify the student for the program:
 - Attendance or officer position at Boys/Girls Nation or State summer conference
 - Member of a National Honor Society
 - ✚ However, serving as an *elected officer* for the organization *for the entire school year* is acceptable
 - A founder or chairperson of a self-created group
 - A participant, captain, or officer in Mock Trial, Debate Team, Model UN, or other academic club, conference or competition, where the primary engagement is for individual educational enrichment
- e. Cannot have been selected as a Delegate to Washington, D.C. in past years.

II. To participate in the program:

- a. Delegates must be able to remain with the group throughout the entire program week. No tours or trips will be permitted by individual Delegates while traveling to or from Washington, D.C. or while in Washington, D.C. This policy includes any other outside activity, conference, scholarship competition or event of another organization which is conducted in Washington, D.C. or the surrounding area during the time frame of the USSYP week.
- b. All travel is scheduled during these time frames pending weather conditions and flight availability, no exceptions. The program requires that the student completely block both arrival and departure days to receive the travel benefit.
 - i. Arrival: **Saturday, March 2, 2019**
 - ii. Departure: **Saturday, 9, 2019**

III. Special arrangements:

- a. No arrangements for individual religious practices or services other than dietary guidelines will be made during the Washington week. This policy will be strictly observed from the time the student delegates arrive at the Washington area airports, train station and program sites until they return to their home states.

IV. Selection process:

- a. Nomination of outstanding junior or senior by high school principal. If home-schooled, may be nominated by church or civic leader.
- b. Selection of ten finalists by panel including Indiana Bar Foundation, Indiana Department of Education, and Indiana Association of School Principals, based on:
 - i. Application signed by principal;
 - ii. Student essay on a given topic relating to the U.S. Government and the political process. The essay is the major factor in the selection process.
 - iii. One-page student resume;
 - iv. Letter of support from principal (from church or civic leader if home-schooled).
- c. Ten finalists complete a written examination and an individual interview in Indianapolis, **9:30am to 4:00pm, Saturday, October 27, 2018**. NOTE: All expenses, including transportation to and from Indianapolis, are the responsibility of the local school and/or parents or guardians of the finalists. Tests and interviews will only be done on this date.

V. Criteria for selection of ten finalists:

- a. Nomination form: filled out completely and must bear the signature of the student's high school principal.
- b. Student essay:
 - i. Should take and defend a position on the assigned topic:

In President John F. Kennedy's inaugural address, he challenged Americans with this now-famous quote: "And so, my fellow Americans: ask not what your country can do for you—ask what you can do for your country."

 - **How would you answer his question? What can and should an American do for his or her country? Why?**
 - **What knowledge, skills, and attitudes enable individuals to "do something" or make a positive contribution to their country?**
 - ii. Essays should be specific, concise, well-organized, and free of errors in grammar and spelling.
 - iii. Must be 350 – 500 words in length, written by the student;
 - iv. Must be typed; and
 - v. Should have a title at the top of the page, reflecting the view of the essay.
- c. Student resume: Should be *one page* describing the student's accomplishments, work experience, service to family, school and community, etc.
- d. Letter of support from principal: Should help to document the student's accomplishments in student government and contributions to school and community.
- e. All documents post-marked by **September 28, 2018** and mailed to the Indiana Bar Foundation. ***Electronic submission of documents will not be accepted.***

VI. Indiana Bar Foundation process for selection:

- a. A team of reviewers will read all submitted essays blindly (separated from the applicant's name and application materials). Each reviewer will assign numerical scores to the essays based on their clarity, thoughtfulness, persuasiveness, and quality of writing. The applications of the top ten scored essays are then reviewed to confirm that these applicants meet all the eligibility criteria. The ten top-scoring applicants who also meet the eligibility criteria are then invited to come to the Indiana Bar Foundation for the written exam and individual interviews. Each portion of the written exam and interviews are scored. The finalists with the top two highest scores at the end of the day are chosen as the Indiana Delegates. The two applicants with the next highest scores are selected as the two Alternates.

VII. Notification of finalists:

- a. The ten students selected as finalists will be notified by a phone call and/or email to their principal in October of 2018. Principals who have not received notification by the end of October will know that their nominee has not been selected. The ten finalists will also receive a packet of information via email with an acknowledgment receipt requested.

VIII. Criteria for selection of two Delegates and two Alternates:

- a. Written test: Students should perform well on objective and essay questions relating to state and federal government and U.S. political systems.
- b. Individual interview: Students should demonstrate an understanding of current events and political issues of concern to the U.S. Government and general public, while having:
 - i. The ability to communicate effectively;
 - ii. The ability to deal with diverse opinions and viewpoints; and
 - iii. Good personal presentation.

IX. Notification of Delegates and Alternates:

- a. Delegates and Alternates will be selected by December 1, 2018. Their packets will be sent to the Hearst Foundation for approval. Once the Hearst Foundation finalizes the choices, the Indiana Bar Foundation will be given clearance to announce their names to the public, and they will be notified. This will be announced in December by the Hearst Foundation. At that time, the Hearst Foundation will send Delegates information on travel arrangements, rules regarding student activities and behavior while in Washington D.C. and regulations governing the use of college scholarships.
